NCC reports steady growth in telecom subscriptions




The Nigerian Communications Commission (NCC) has revealed a consistent rise in active voice and internet subscriptions, despite a decline in teledensity, according to the latest telecommunications statistical indicators. The metrics have been adjusted to align with the Nigerian Population Commission's projection, bringing the current population estimate to 216,783,381 as of 2022, up from the previous projection of 190 million people.

Dr. Reuben Muoka, NCC's Director of Public Affairs, stated that with this adjustment, the nation's teledensity dropped from 115.63% to 102.30%, and broadband penetration decreased from 45.47% to 40.85% in September 2023. However, active voice subscriptions witnessed a marginal growth from 220,361,186 to 221,769,883, and internet subscriptions also experienced a slight increase from 159,034,717 in August 2023 to 160,171,757 in September 2023.

In October 2023, the industry saw a 0.19% growth in active voice subscriptions with a teledensity of 102.49%, and internet subscriptions rose by 0.60%. The trend continued in November with a 0.46% growth in active voice subscriptions and a 0.57% increase in internet subscriptions compared to October 2023.

Teledensity, an index prescribed by the International Telecommunications Union (ITU) for measuring telephone penetration in a population, dropped as a result of the adjusted metrics. Dr. Aminu Maida, the Executive Vice-Chairman of the NCC, endorsed the adjustment process, emphasizing its role in maintaining data integrity and accurately measuring the Commission's progress in increasing broadband penetration, improving service quality, and expanding population coverage.



Ivan Moroke, the CEO, South Africa Kantar, during his session in the event held at Marriott Hotel, Ikeja, Lagos with theme: "Brands of Tomorrow making growth real" harped on the need for brands to make meaningful difference in the life of consumers by crafting Unique Value Proposition (UVP).

'Which of the brands in your personal life are you prepared to pay a bit more for? If you are prepared to pay for that, I can challenge you on that because it is different. But we've got a brand girl in South Africa. She always says there's a difference between different and meaningful differences. She says, "if you are different without meaning, you are just weird". I think it applies to brands as much as it applies to people. You are just a strange individual if you are just different without valuable meaning. You must be different with purpose. The meaning behind this is simply that, the difference is the rocket pool that does growth.

The Kantar boss also explained how Kantar leverages insights to shape brand's growth across the continent with its diverse portfolios of business strategies which include consulting practice used in positioning brands with a valuable market difference in an ever-changing market environment that demands agility.

"We want to be an indispensable brand partner for you. What that means is, before you make any marketing decision, our vision is to say, we can help you achieve that. We are in a brand planning stage; we are in a business process. We are like that in East Africa, in South Africa, and that's how we are here. We've been talking about how Nestlé has rationalized products in the market. This is what portfolio strategy is. That's what we specialize in. And we've done phenomenal work with Nestlé across the world on geo-portfolio strategy.

"Sometimes, all you might need is category insights. Where is the category going? What are the kind of things we should be looking at or we should be worried about? That's what we specialize in. If you are not innovating, you are going backwards, period. It doesn't matter what category you are in. Because if you think about it, and regardless of your sector, have you realized how your competition is changing? Sometimes, you don't even see them where they are coming from. Different people are offering different things, which is why they are coming with different innovations."


He also emphasised the importance of being innovative to revolutionise products with new definitions of value for consumers' general acceptance irrespective of price.

"Disruption is one of them, but we've made a study about disruption. That's what makes the difference. And it's based on data about 20%. It's like shaking things up. Brands that do that get 80% in the way. There's always a misnomer with marketers. They think the only way to be a bit of a disruptor is to be fintech. It's not true. There's a difference between being a disruptor and being a challenger brand. For example, if you think about Apple, it's is not a challenger brand. That's a main, big brand. But it's different, right? It's disruptive in terms of what they try to do and how they communicate it."

Moroke pointed out that successful brands are not only meaningfully different but also relevant and always strive to create positive changes in society by tackling impactful and meaningful social issues that align with their ethos by focusing on climate change, racial injustice, poverty, war, sustainability and several others.

"What does insight mean for innovation? What does it mean for the position of your brand? It's about pricing and segmentation. That's what we specialize in. We do those strategies and it is about creating value. There are different ways we can create value; we can do it with our shareholders, and you can measure some acquisitions, cost cutting, so the problem with that is not sustainable. The only sustainable growth of value is demand-led value. It's what consumers want. If you can create value by absolutely creating demand from consumers, then it's far much more sustainable. And that's what we are passionate about."

The event showcased Kantar's blueprint for sustainable brand growth for winning marketers where diverse speakers discussed how to turn insights into actionable strategic plans to achieve results and outcomes that accelerate brands' growth.



IMC leaders raise concerns over Al efficiency and job preservation

Striking a balance between Artificial Intelligence and human value has remained one of the heated and inexhaustible topics driving the conversation among industry leaders and major players in the Integrated Marketing Communication landscape.

The fear, agitation and worries that the new technological invention has come to replace human values and render many employees jobless are palpable. This is due to the noticeable efficiencies that are recorded by organizations who carefully and purposely deploy Artificial intelligence to achieve set goals or possibly do human jobs.

While humans work according to the limit of their strength, health, and length of working hours, AI defies all natural limitations to deliver on specific mandates with better efficiency and accuracy. As robots, they do not fall sick, have emotional challenges, or demand pay increments. Their salary and motivation are on energy source and maintenance.

With a strong projection that AI will make a significant advancement globally in 2024, the reality of job loss owing to the efficacy of the emerging technology is speedily crashing down on many employees.

Speaking recently on the efficiency of

Artificial Intelligence and preservation of human jobs, a Tech expert, Olufemi Adeagbo identified those who are competing with the technology as far as job productivity is concerned.

According to him, those who have jobs as researchers are under pressure. Content creators are under pressure. Data entry, manufacturing, financial analysts, stock advisers, psychologists, and legal assistants are competing with AI. Coders and cybersecurity specialists are also in this category. Adeagbo who is the CEO of Comnavig ICT Advisers, stated that he cannot think of any job role that AI can't impact.

"Anything humans can do; AI can ultimately be purposed to do much better and at scale. The extent of impact and sustainability may be an issue to debate. Jobs that rely on repetitive and parameterbound variables such as manufacturing, and logistics jobs will be impacted too.

"Individuals should also be able to explore all their interests within the confines of the law. The law exists to promote the ideals of normalcy. Unrestrained and unregulated AI can upend social order, decimate values, and disrupt political spaces, and even economies in very profound ways.

"Social media has done its bit and people are divided on whether the net

gains justify the adverse aspects that have seen societies become more divided, zombified in many cases by fake news, and addicted now to all sorts of aberrative behaviour. AI is much more powerful, and a balance must be found in focused, deliberate, and strategic regulation." Adeagbo stated this while appearing on a National TV.

Also giving his professional perspective on the matter, the Chief Executive Officer, Kantar, Ivan Moroke revealed that every progress of technology is real and it has an impact on jobs.In his words, "While Artificial Intelligence has impacts on jobs, it however creates a new set of jobs we can never even have imagined. We will not be sincere to say there is no danger of artificial intelligence on jobs but at the same time, we must realize that new industries get created. So that is the balance because you have to admit that the new technology has made a big difference in terms of improving efficiency and time saving."

According to Stephen Okpara, Product and Quality Assurance Manager, Samsung, the solution is for people to upgrade their technological knowledge and adapt to the new innovation so as to remain relevant in any line of job they are.

"The truth is AI has come to stay and there is nothing anyone can do about it. What you can do in hours, AI will do it in two minutes. It works faster and more efficiently. The whole essence is to help you to be more productive. People have this mindset that the advent of Artificial Intelligence will make people lose their job. That is not true. When computers came, instead of rendering people jobless, it further created opportunities for people to be more engaged and skillful. Today, technology has given people the privilege to expand their knowledge base and increase productivity.

"With Artificial Intelligence, all we need is to upgrade our technological knowledge and adapt to the new innovation. It is only those who are not ready to embrace the new normal that will be rendered jobless in the long run," Okpara noted.

CONSUMER-CENTRIC BRANDS AND TASKS OF PROMOTING RESPONSIBLE DRINKING

For most consumer-centric alcoholic brands, the total well-being of the consumers remains their ultimate goal. Against this backdrop and in the bid to promote responsible drinking habits, several brands have initiated remarkable and strategic steps to ensure that they help their teeming and loyal consumers maintain and sustain their prestige as responsible consumers. They have achieved this feat by introducing informative and enlightening campaigns that caution consumers' drinking habits in a reasonable manner.

Most renowned global brands who understand that excessive alcohol consumption can have severe and detrimental impacts on consumers have continued to warn consumers of the various implications associated with excessive or irresponsible drinking habits.

Apart from promoting moderation, they are also tackling the challenge of underage drinking, drink driving as well as binge drinking.

In Nigeria, many brands are working tirelessly to ensure that they eradicate the menace and dangers associated with underage drinking through various marketing strategies.

Heineken, in its bid to change consumers's attitude to drinking allocates 10% of its total media spend to responsible drinking campaigns. Sampson Oloche, Head – Premium, Portfolio, Nigerian Breweries, had stated in an interview that Heineken has a global mandate of 10% of the beer's media spend. "So one out of every 10 Naira spent in the media has to go into this campaign. There is no regulatory or government regulation on this. This is just us, being a corporate citizen, to say we take 10% of our media spend on promoting this, then we are doing a good job educating people and reminding them that they should stay safe."

Adebowale Bojuwade, the Senior Brand Manager, Seaman's Schnapps, confirmed that Seaman's Schnapps has introduced various initiatives to accelerate the drive for change by engaging consumers through awareness campaigns, enlightenment programmes and partnership with stakeholders such as the Federal Road Safety Corps.

"As a brand, we are very conscious about responsible drinking and we hold our corporate social responsibility highly because we ensure that every communication messages we disseminate out there will always reiterate our commitment towards the promotion of responsible drinking among our consumers, especially in emphasising the age guidance and control while also stressing the official approved age which is 18 years plus.

International Breweries Plc, also related how it has been involved in a more futuristic campaign in line with global best practices projected to be implemented till the end of 2025. It further explained that the business of International Breweries is more than making a sale, rather, a focal point of making the world a better place and bringing cheers to its stakeholders.

"Our commitment extends far beyond saying "drink responsibly": it spans our Global Smart Drinking Goals, the work of the AB InBev Foundation, the commitments of our brands and the behaviours that we ask our consumers to practice every time they pick up a beer. We recognise that millions of consumers enjoy our products every day, so year-on-year, we continue to work across sectors to disrupt harmful drinking."

Guinness Nigeria revealed that it has been at the forefront of championing a responsible drinking culture for a very long time in its mission to ensure that its consumers are not exposed to dangers.

"We are proud of the role our brands play in the lives of so many Nigerians, but we also acknowledge that excessive or inappropriate patterns of alcohol consumption may cause health and social problems. Our actions in promoting responsible drinking are occasionally greeted with skepticism: why would a brewing company wish to encourage people to consume less of its products? The answer is simple. First, we want to do what we can to ensure that our brands are not a cause of harm in society. Second, if misuse persists, campaigns against the promotion and sale of alcohol beverages may follow, potentially affecting our business. For these compelling reasons, we work to find a responsible, sustainable place for the moderate enjoyment of our brands in Nigeria."

Meanwhile, feelers from MARKETING EDGE's intelligence in Lagos metropolis showed that some consumers, especially young people have not felt the impact of the campaigns.

Damilola Adepoju, a sales representative, said some of the brands are contradicting themselves with their campaign initiatives.

"To me, all these brands are just selling their brands; there is no social responsibility in anything they do as they claim. Most times, they are even contradicting themselves, because

you are admonishing a consumer to drink responsibly and at the same time, encouraging him to buy two and get one free. What does that mean? How can such a person think of drinking responsibly? After all, awoof, they say, dey purge belle."

James Dogo, a financial analyst, blamed the unregulated selling of alcohol to lack of stringent and effective law and order among government agencies.

"I don't know the role that Federal Road Safety Corps plays, because every day, we see hawkers at the bus-stop selling sachet alcohol, whereas the law says don't drink and drive. Yet they are selling these things at the bus-stops. Who are they selling it to? Of course, drivers and conductors. But you will still hear FRSC officials say they are doing this or that campaign. What is the essence of such campaigns without impact?

Joseph Ike, a sports enthusiast also corroborated the first respondent by adding that whatever measures brands are putting in place have not been effective enough. He noted that it should not be a one-off measure but a process that will sensitize and sanitize the society off irresponsible drinking habits.

However, Bidemi Odukoya, a restaurant owner noted that brands are playing their parts but that the ball is in the court of consumers to caution themselves.

"I know many brands who carry out adverts endlessly to caution consumers on the need to avoid drinking while driving, some even jokingly tease that if you must drink, then drink water while driving. It is left for an individual to be cautious, even makers of cigarette warning that smokers are liable to die young haven't stopped people from smoking. Although brands need to still do more, especially by taking such campaigns to our bus-stops because alcohol abuse is worse there. In fact, I will say that is what most of them use to brush teeth in the morning, literally speaking."

Meanwhile, the umbrella body of the Distillers and Blenders Association of Nigeria, DIBAN, on its part disclosed that as a fulfillment to its corporate social responsibility, it launched a 170 million naira advocacy campaign against irresponsible and underage drinking of alcohol some time ago.

This plan involves the heavy use of radio, billboards and social media to propagate the carefully crafted messages which are expected to cause behavioral changes in consumers.

The Chairman of the association, Chief (Engr.) Patrick Anegbe said: "Our goal is that anyone below the age of 18 years must not drink alcohol and even the adults who want to drink must drink responsibly. We are socially responsible and that is why we are saying the underage must be protected, even if our bottom line is affected."

INFLATION: DOES YOUR BRAND EQUITY JUSTIFY YOUR PRICE POINT?

-Brand managers must understand that the justification of a price point is not merely a numerical exercise but an intricate connection between consumer perception and the brand's ability to deliver on promises. Only brands with strong equity can weather the storm of economic uncertainty by upholding the trust they've meticulously built.

ow, more than ever, as we navigate the intricate terrain of an economic crisis coupled with inflationary pressures, the need for brands to judiciously justify their price points is a critical aspect that can make or break their resilience in the market.

Once-affordable commodities are slipping out of reach, leading some businesses to exit the country, and others are forced to shut down certain product categories.

During inflationary periods such as this, consumers are also forced to make tough choices about where to allocate their limited resources. As a result, a brand's ability to maintain price appropriateness becomes a critical factor in retaining customer loyalty; brand managers must also now tread with caution.

"Price is vital," said Akin Afere, Associate Director, for Nigeria at Kantar, as he shed light on the importance of understanding the intricacies of consumer behavior during economic challenges.

"During times like this, you need to understand the pricing power of your brand and be meaningfully different. What do your customers value most about your brand? You need to understand who your buyers are. You cannot exist, and your product cannot exist without its buyers. So, how predisposed are those buyers to your brand versus other brands in that category? Secondly, you need to understand price sensitivity. We've talked about inflation, and we'll allude to it a lot more as it affects people differently, affecting the way that they make their plans and decisions," Afere explained, adding that this is where the perceived value, backed by strong brand equity, becomes the compass guiding consumers through the maze of rising prices.

During economic upheaval, consumers scrutinize their spending with a discerning eye, making decisions based on perceived value and brand trust. This is where brand equity comes into play – the intangible yet immensely valuable asset that encapsulates the trust, loyalty, and perceived value consumers attach to a brand. According to Afere, the key lies in ensuring that price adjustments align with the intrinsic value consumers associate with the brand. It's not just about passing on increased costs; it's about preserving the delicate balance between price and value.

"Does your brand's equity justify the price point? Those are questions we need to ask ourselves. Especially in an environment like this. What you shouldn't do is say, 'How do I just get volume and increase my capacity to reach the audience in any way necessary? Or pushing for promotions; you know, it seems like a lowhanging fruit in inflationary times. But we can tell you from studies and research that those short-term gains will not stand the test of time. There are better ways," Afere continued.

As we find ourselves in an economic crisis, marked by low purchasing power and a surge in discretionary spending due to inflation, consumers are reevaluating their priorities. The very essence of brand equity lies in the emotional connection a brand has fostered with its consumers. It is this emotional tie that influences the perceived value of a brand and, consequently, justifies its price point.

A robust brand equity acts as a shield during an economic crisis, allowing a brand to command a price that aligns with its perceived value. Consumers, even in the face of financial constraints, are more likely to stretch their budgets for a brand they trust and value. This trust is earned through consistent quality, reliability, and a commitment to meeting or exceeding customer expectations.

In essence, the relationship between brand equity and price appropriateness is a symbiotic one. As brand equity builds and strengthens, it provides the latitude for a brand to navigate through economic crises with the flexibility to adjust price points judiciously. Conversely, maintaining price appropriateness during inflationary periods safeguards the hard-earned equity by ensuring consumers continue to see value in their purchases.

Heineken records huge drop in volume sales figures in Nigeria, Vietnam

Heineken, the world's second largest brewer, has recorded a significant drop in volume sales of its beer, as the Dutch brewer's stocks fell by 6.5% last week.

Heineken attributed much of the decline to the disappointing performance in Nigeria and Vietnam, with both regions accounting for more than 60% of the volume drop in 2023.

In a statement, Heineken said it expected its operating profits throughout the year to see a "low to high single digit increase".

Heineken chairman

and chief executive, Dolf van den Brink, said, "We feel good about where the company is going, but we continue to do that in a turbulent world so that's why we have deliberately chosen a relatively wide range."

He added that raising the prices of Heineken beers last year had undoubtedly "impacted volumes", which fell by 4.7% (more than the estimated 4.4% decline) in 2023. van den Brink, however, didn't rule out further price increases in 2024.

Instead, he hinted that the pace of price increases will be moderate this year, but pointed out that input costs are still rising.

Heineken raised its beer prices by double digits in the first half of 2023, and again, by single digits, in the second half. The hikes saw Heineken's average prices increase by 10.2% worldwide.

van den Brink also said, "Strong pricing to offset very high input and energy cost inflation and volatile macro-economic conditions in some key markets affected our volume momentum."

New tax laws in Brazil (Heineken's second biggest market) are also likely to impact the company's bottom line in the coming years, as Heineken will see its global tax rate jump from 26.8% to 29% in 2025.

Analysts called the full year forecast underwhelming as Heineken's stocks slid in the wake of the announcement.

WARC forecasts global sports media rights spend to reach \$61bn in 2024

The projected global expenditure on sports media rights is estimated to reach \$61 billion this year. However, brand advertisers encounter challenges due to the fragmented media landscape.

In the United States, brands are anticipated to allocate an additional \$2 billion towards advertising during the Paris Olympics, while Euro 2024 is expected to drive €250 million in additional ad spend across Europe. Despite these boosts, they are unlikely to counteract the ongoing decline in TV viewership.

In a time when marketers increasingly rely on sports for widespread exposure, the sector faces fragmentation. Live sports rights are becoming dispersed among various platforms including broadcast, over-the-top (OTT) or streaming services, and mobile apps. Additionally, social media platforms are gaining prominence among fans.

"Sports Media in the Era of Fragmentation," WARC Media's latest Global Advertising Trends report, delves into the evolving media landscape of sports, highlighting the challenges and opportunities for brand advertisers. It also explores how rights holders plan to maintain the economic sustainability of sports in the years ahead.

Alex Brownsell, Head of Content, WARC Media, says: "Sport is one of the last providers of true 'water cooler moments', and this year's bumper schedule of major sporting events, such as the summer Olympics and Paralympics in Paris, the UEFA European Football Championships, and the T20 Cricket World Cup, will provide advertisers with unrivalled means to achieve mass reach.

"However, these enduring qualities are under threat as consumption fragments. In this report we take a closer look at the current state of sport advertising at a time when media consumption poses a dilemma for brand advertisers."

The WARC report on "Sports media in the era of fragmentation" reveals several key insights. Despite the fragmentation of media, major live sporting events still attract massive audiences. For instance, the Super Bowl LVII witnessed over 115 million viewers across Fox properties, marking it as the mostwatched telecast in US history. Television networks continue to invest significant sums in securing sports media rights. Global spending on these rights is projected to reach \$60.9 billion in 2024, a notable increase of 18.9% from prepandemic levels. Traditional broadcasters are intensifying their efforts to retain access to premium sports content.

2024 is poised to be significant for live sports, with the return of major events such as the Paris 2024 Summer Olympics, UEFA Euro 2024, and the T20 Cricket World Cup. Broadcasters and streaming platforms anticipate heightened viewership during these events. Despite the prominence of live sports, linear TV ad spend continues to decline in several regions. In the UK and Germany, linear TV spend is expected to decrease, while France experiences a slight increase. In the US, the recovery in

linear TV spend is attributed more to favorable year-on-year comparisons and upcoming events like the Presidential election rather than sports.

The fragmentation of sports rights poses challenges to achieving mass audience reach. NFL coverage, for example, is spread across various platforms including broadcast TV, cable networks, OTT services, and mobile apps, making it increasingly complex for fans to access all live games.

Social media platforms are emerging as significant channels for sports consumption, particularly among younger demographics. Approximately 93% of individuals aged 18-24 engage with sports content on social media weekly. However, Gen Z fandom tends to be more fluid, focusing more on athletes' narratives rather than specific teams or competitions.



to Programmatic Ad Spending Forecast H1 2024.

According to the latest study by Insider Intelligence/ eMarketer, a 15.9% growth rate and 91.3% of all ad spending are expected in the segment. The report envisaged that the it will experience a boom in 2025, with programmatic spending expected to total \$178.25 billion. The study, however, showed that nonprogrammatic will grow at only a third of that rate in 2024 at 5.3%.

According to the Mediapost, cookie depreciation has hit ad spending as programmatic advertisers have been "refocusing strategies around first-party data and investing more heavily in closed and private ecosystems. "This will leave the open exchange with less than 10% market share by the end of 2024," the report said.

In another revelation, it stated that open exchange ad spending represented 74.5% of the programmatic display market when eMarketer began tracking it in 2013. Ever since, advertisers have invested heavily in private marketplaces and closed ecosystems like social media platforms and retail media networks (RMNs), which fall under programmatic direct.

Citing a survey data from the Interactive Advertising Bureau (IAB), while applauding the immense contribution of measurement, the report recorded, "As signal loss reaches a fever pitch with cookie deprecation, ad buyers and sellers are harnessing their own consumer data for programmatic activation across transaction methods. Six in 10 buyers reported they'd be focusing somewhat or significantly more on ad placements with publishers with first-party data in 2024. November 2023 CTV ad spending was expected to be \$1 billion less than the sum originally predicted."

Global gin market to reach \$30.1 bn by 2031

recently published report made available by Growth Market Reports valued the global gin market size at USD 22 billion in 2022, and projected it to reach USD 30.1 billion by 2031. It's also expanding at a CAGR of 4.69% from 2023 – 2031.

Giving an estimation in litres, the report declared that the Gin Market size will reach 0.86 billion liters in 2024, and is expected to reach 1.13 billion liters by 2029, growing at a CAGR of 5.38% during the forecast period (2024-2029).

Providing a holistic view of the market dynamics, the analysis noted that the gin market has experienced remarkable growth in recent years, driven by several factors, including changing consumer tastes, the rise of craft distilleries, and innovative marketing strategies.

Acknowledging that the market reached saturation

point pre-Covid-19 and decimated by the pandemic, the data demonstrated that as a result of this shift, craft gins will struggle to progress, particularly as brands with international recognition move to occupy an increasingly challenging premium space.

The report attributed the upward move to increasing demand for handcrafted and premium gin beverages, which has gradually become a global trend in consumption. Another report disclosed that Gin garnered its popularity through the power of three main reasons which are its taste, versatility and the sheer variety of gins and for its distinctive way of reaching the parts of other white spirits just cannot reach.

Although as of 2023, it was recorded that Ginebra San Miguel was the leading brand of gin worldwide, selling over 37 million 9 liter cases, while ranking second, Gordon's sold 7.7 million cases of the distilled alcoholic drink. The report showed that the Philippines tops the list of countries with the world's highest per-capita gin consumption.

Offering a robust assessment of the global gin market and its mode of key segmentation into various types, the market analysis underscored several brands leading in this category to include brands such as Plymouth Gin, the popular and legacy London Dry Gin, Old Tom Gin and many others

Other key global players are Asia Pacific, North America, Latin America, Europe, Middle East & Africa while companies who have remained major players are Bacardi, Davide Campari-Milano N.V., Diageo, Pernod Ricard and others.

Coca-Cola introduces Coca-Cola spiced and spiced zero sugar

he giant carbonated drink The Coca-Cola Company is adding new flavours to its portfolio by introducing Coca-Cola spiced and Coca-Cola spiced zero sugar, the first permanent offering in over three years.

According to the company, the two new flavour drinks will go on sale on February 19th, in Canada and USA. The drinks will be available in most national retail stores across a variety of sizes and packaging formats, including 12 ounce cans, tenpacks of mini cans, and two-liter bottles.

Despite the name, those sensitive to spicy foods need not be intimidated by the new flavour. In a fact sheet, the brand makes clear that "Coca-Cola Spiced is not spicy," while simultaneously describing it as "Coke's boldest tasting brand innovation



yet."

Rather than a capsaicin-heavy assault on taste buds, the new addition seems to be a blend of the novel and familiar. The company described the Spiced flavor as blending "the iconic taste of Coca-Cola with a burst of refreshing notes from raspberry and spiced flavors."

The branding and packaging for Coca-Cola Spiced was designed to be in line with the Coca-Cola master brand's visual identity, while adding a "swirl made up of raspberry-inspired colors" to the trademark red color long associated with the soda. "Coca-Cola" is prominently featured in bold font on both varieties, in white for Coca-Cola Spiced, and black for Coca-Cola Spiced Zero Sugar.

Coca-Cola developed the new flavour based on insights on evolving consumer preferences. According to the company, there has been a 124% increase among consumers in willingness to incorporate spice in beverages since 2019, as well as a 25% increased interest in raspberry soft drinks over the course of the last four years. The company also cited "over 5 million" raspberry servings poured from its Coca-Cola Freestyle machines just in 2022.

Coke has been exploring ways to get younger drinkers excited about its signature cola.





Accelerated Learning Project improves education in Kano schools





nder the auspices of the Partnership for Learning for All in Nigerian Education (PLANE), the Accelerated Learning (AL) project has been making significant strides in enhancing educational outcomes across colleges in Kano.

Launched in April 2020 and slated to continue for nine years, the AL project, funded by Foreign, Commonwealth and Development Office (FCDO), has received commendations from educators, mentors, and teachers for its effectiveness in transforming the learning experience.

The PLANE programme is being implemented by a consortium of organisations led by DAI, with the British Council focused on the Accelerated Learning (AL) part of which it implements with Teaching at The Right Level (TaRL) organization.

This year's edition of the AL project in Kano witnessed widespread participation and positive feedback from stakeholders. School principals and teachers lauded the initiative, highlighting its pivotal role in addressing the pressing needs of the education sector.

According to a school principal in Kano, "PLANE Accelerated Learning is one of the greatest things to happen to education as far as my experience and my involvement in the whole project are concerned. Because the accelerated activities is what is needed at this right time."

Moreover, teachers emphasized the collaborative nature of the

project, describing it as a partnership between the British Council and the colleges they work with.

Beyond focusing solely on educating children, PLANE ensures that stakeholders, including teachers and guardians, receive immersive training to equip them with the necessary tools for seamless task execution.

"We attended a series of training. We started with nine days trainings, after which we went for field trips and then for another refresher training for four days pertaining to this programme," shared a teacher, reflecting on the comprehensive training sessions conducted as part of the AL project.

Under PLANE AL, teachers undergo rigorous training and are subsequently tasked with training their peers before engaging with the students directly. This cascading approach ensures that the benefits of the programme reach a wider audience, ultimately enhancing its impact.

"When we get back to our different schools, we start with assessment of my children, divide them into groups; dual language and maths," explained a participating teacher, highlighting the structured approach employed in implementing the AL project.

Assessments conducted during the programme revealed substantial improvements in literacy rates among participating students.

A school administrator noted a significant reduction in the percentage of children struggling with basic reading skills following the intervention.

"Unlike the conventional schooling system, it came with assessing the children, knowing their position at a particular time. And then after the intervention, we see where they are and you find out that we have the baseline whereby you have more than 75% or 80% of children in literacy. They cannot recognise even letters, you know.

"But after the training, after the intervention, you find out that percentage has actually reduced drastically and the same thing for those children who were not able actually to read maybe small sentences, we have found at the story level, which is an achievement which is vividly clear," the administrator remarked.

Furthermore, teachers praised the inclusive nature of the AL project, particularly its use of the dual-language method, which allows them to leverage students' mother tongue before transitioning to English.

"You see, there's something special I love about the Accelerated Learning Project. It is inclusive. So this dual language method employed by the Accelerated Learning project helped me to teach my students using their mother's tongue. And then I later transitioned into the target language, which is the English language," expressed another teacher.

Beyond Kano, PLANE operates at the federal level and in five states, including Kaduna, Jigawa, Yobe, and Borno, with a focus on strengthening education systems and optimizing government expenditures.

The programme's strategic interventions encompass foundational skills development, education in emergency situations, and community-centered initiatives, all aimed at fostering sustainable improvements in Nigeria's education landscape.

Through collaborative efforts with government agencies, civil society organizations, and other stakeholders, PLANE continues to drive positive change and unlock the full potential of education in Nigeria.

Al is redefining Marcom, Manufacturing, Real Estate, Telecoms, Banking and all sectors

he advent of Artificial Intelligence (AI) means that the future of the creative economy, including marketing and advertising, telecom, manufacturing, construction, computing, banking, and other processes now lie in the collaboration between machine learning technology and humans. With the rise of AI as a significant player, any sector of the global economy that fails to incorporate the technology will be left behind.

In 2023, the huge market for AI technologies amounted to about 200 billion U.S. dollars. According to a recent report by PriceWaterCoopers, over 30% of companies utilize AI in some form already. PwC also estimated that AI will contribute a staggering \$15.7 trillion to the global economy by the end of 2030.

Specifically, one of the most profound impacts of artificial intelligence on

advertising and marketing is the ability to deliver hyper-personalised experiences to consumers. Brands are using machine learning algorithms to analyse vast amounts of data, ranging from user preferences and behaviours to demographic information.

In the context of manufacturing, AI generally refers to the application of narrow AI, involving technologies such as machine learning, neural networks, and robotics. AI can also optimize production processes by predicting and reducing downtime, improving quality control, and enhancing supply chain management. For example, AI-powered machines can detect anomalies in the production line in real time, allowing for swift corrective actions and reducing waste. Additionally, AI can help in predictive maintenance by analyzing data from machine sensors to predict potential failures before they occur.

In the real estate sector, artificial

intelligence embeds high-grade intelligence that helps acquire precise market projections and create smart investment strategies by leveraging big data analytics to process vast amounts of information. From automated property valuations to personalized customer experiences, AI is undoubtedly reshaping the industry with profound tech-driven solutions.

What's more, the influence of AI in real estate is tremendous, with a projected valuation of US \$1335.89 billion by 2029 and a phenomenal Compound Annual Growth Rate (CAGR) of 35%.

Before now, construction has been suffering from budget overrun. And a recent McKinsey report estimated that large construction projects usually exceed 80% of the planned budget. But, the budget overrun is currently tackled by AI. Some AI startups are solving the problem using robotics, LIDAR imaging and autonomous robots to capture 3D images of construction sites. Thereafter, the AI algorithm analyzes data and turns it into insights, which are used by project managers to tackle any construction project issue.

The global AI in telecommunication market size was valued at USD 661.57 billion in 2024 and is expected to expand at a CAGR of 27.25% during the forecast period, reaching USD 2.96 trillion by 2031, according to a McKinsey report.

Leading regions in the AI telecom market include North America: USA, Canada, Mexico; Europe: Germany, UK, France, Italy, Russia, Turkey; Asia-Pacific: China, Japan, Korea, India, Australia, Indonesia, Thailand, Philippines, Malaysia, Vietnam; South America: Brazil, Argentina, Columbia; Middle East & Africa: Saudi Arabia, UAE, Egypt, Nigeria, and South Africa.

With online and mobile playing a huge role in the banking sector, AI has become the most effective analytical solution and method to help customers better and manage internal purposes. Also, with several challenges such as scams, security, customer experience, and monetary forecasting facing the banking sector, AI promises to proffer the best solution for personalization, customer experience, fraud prevention, professional financial errors, and many more.

However, despite the cutting-edge transformation projected in the innovation space in 2024, there is a premium for human-crafted, human-created products because humans still have a major role to play in the creative market. The rumbling in the marketing communications and other sectors of the economy about machines replacing employees doesn't hold as humans basically need to chart a creative and innovative way forward to work with the advancing technology that AI offers.

According to Laurent Thevenet, head of creative technology, Publicis Groupe APAC & MEA, "Whatever AI tools produce today still needs strong human guidance. I have been playing in this new field since 2019 and the working model remains the same for now. It's about humans and machines working together."

For Cheuk Chiang, CEO of Dentsu Creative, "AI should be used to augment and enhance our teams to increase productivity, efficiency, and return on investment. A great analogy would be generative AI as a sous chef or kitchen assistant. A sous chef helps with the preparation to realize the master chef's vision. AI helps prepare our thinking and craft to realize our creative vision."

In a separate report, while 57% of industry respondents said most software they use will have AI or automation capabilities built-in by 2024, 56% said most people will use a generative AI tool like ChatGPT to assist them in their jobs by the same year in view.

The significant paradigm shift occasioned by generative AI has disrupted how marketers and advertisers deploy their strategy. New AI tools are radically changing how consumers and brands engage with each other. The brands to watch and forces behind them in 2024 will be the ones that acquire a new set of skills and tools to thrive. Also, future-fit agency practitioners in Nigeria must continually evolve their strategies and tactics if they want to remain relevant.



The advertising industry has been also projected to witness exponential growth across the world, a development that is generally attributed to the increasing focus on the regulatory measures of the integrated marketing communication sector.

Advertisers" Association of Nigeria (ADVAN) is the umbrella body for advertisers in the country. ADVAN members comprise of some of the biggest companies in Nigeria with a yearly marketing budget of over N100 billion. The big advertisers include Nigerian Breweries, MTN Nigeria, Airtel Nigeria, Unilever, FrieslandCampina WAMCO, Guinness Nigeria, Access Bank, Dangote Group, BUA Group, Ecobank, Zenith Bank, and Fidelity Bank among many others.

Major advertising agencies in Nigeria include and are not limited to Noah's Ark, Insight Redefini, X3M Ideas, SO&U DDB Lagos, and Nitro121.

According to a recent Statista report, ad spending in the advertising market is expected to reach US\$1,084.00tn in 2024. The research emphasizes that TV and Video advertising will claim the largest market share with a volume of US\$337.50bn this year. 

EFCC accuses banks of 70% financial crimes



The Economic and Financial Crimes Commission (EFCC) has accused Nigerian banks of involvement in about 70% of the financial crimes in Nigeria. Ola Olukayode, the EFCC

Chairman, made this known recently in Abuja at the 2023 Annual Retreat and General Meeting of the Association of Chief Audit Executives of Banks in Nigeria (ACAEBIN). He specifically described Nigeria's banking sector as a cesspool of fraudulent activities while mentioning that the ugly development had been raising considerable challenges and concerns to the commission.

Idowu Apejoye, the Director of Internal Audit, EFCC, who represented Mr Olukayode, pointed out a need for concerted effort by relevant authorities and professionals, especially audit executives to prevent and tackle issues of fraudulent practices in the banking sector.

In his words, "Broadly speaking, banking fraud in Nigeria is both inside and outside related. The inside related fraud comprises outright selling of customers' deposits, authorising loan facilities, forgery and several other kinds of unhealthy and criminal practices.

"The outsider related ones

include hacking, ATM fraud, conspiracy, among others. And then the absurd one is when both collaborate, that is collaboration among the bankers and the outsider.

"That one is the one that is really absurd because when you do that, that means you are selling out the system. It is estimated that about 70 per cent of financial crimes in Nigeria are traceable to the banking sector, this scenario is disturbing and unacceptable."

While responding to the EFCC's boss, Prince Akamadu, the ACAEBIN Chairman, explained that banks have been working tirelessly to curb fraudulent activities, while pointing out that the banking sector has done more in the area of Know Your Customer mechanism.

FBN Holdings records 127% surge in profit

n a financial revelation, First Bank of Nigeria Holdings, under FBN Holdings, declared a substantial 127% increase in profit at the close of 2023, reaching N309.89 billion compared to N136.17 billion in the corresponding period of 2022. The unaudited consolidated financial statements, filed with the Nigerian Exchange Limited on Thursday, disclosed significant growth in interest income, rising by 66.27% to N917.71 billion from N551.94 billion in 2022. Additionally, fee and commission income experienced an uptick to N204.90 billion from N143.98 billion in the previous year.

However, FBNH faced a foreign exchange loss of N350.32 billion at the end of 2023, contrasting with a gain of N22.39 billion in 2022. Over 12 months, the total assets of FBN Holdings witnessed a remarkable growth of 59.73%, closing at N16.89 trillion from N10.58 trillion as of December 2022. The liabilities also saw an increase, reaching N15.19 trillion from N9.58 trillion. In 2023, group entities, including FBN Holdings Plc. and FBNQuest Merchant Bank, incurred penalties totaling N17.26 million for late submission of financial statements and breach of transaction rules.

Interestingly, Barbican Capital, linked to former chairman Oba Otudeko, has been identified as the largest shareholder in FBN Holdings with a 13.61% stake. This revelation emerged a day after billionaire businessman Femi Otedola, holding a 5.65% stake, was appointed as the new chairman. The acquisition of shares by Barbican Capital prompted reactions from capital market stakeholders, leading minority shareholders to call for regulatory probes. The Securities and Exchange Commission confirmed an ongoing investigation but has not disclosed its findings. The Central Bank of Nigeria removed Otudeko as FBNH's non-executive director/ chairman in April 2021 due to non-compliance with regulatory control.

CBN raises Customs' FX clearance rate

he Central Bank of Nigeria (CBN) has increased the FX rate for clearance of goods at different import points by N18.44 from N1593.84/\$ to N1612.28/\$.

This was revealed in the latest statement posted on the website of the Nigeria Customs Service (NCS).

According to the post, the

new figure for the exchange rate was introduced on March 11, 2024 and mirrors the prevailing market rate on that day. The naira closed at N1617.96 to the USD on the official window on March 11, 2024.

The Comptroller General of Nigeria Customs Service, Adewale Adeniyi, had earlier stated that following the floating of the naira, the NCS will regularly change the FX rate for clearance of goods in line with the figures from the CBN official market rate.

Following complaints

from the business community over the regular changes in the customs FX rate and the resultant confusion while filling the Form M for the importation of goods, the CBN in February introduced a new policy stating that the FX rate on the date of Form M would be used for clearance of goods.

According to the CBN, the move will quell the confusion around different exchange rates and aid planning on the part of both the Nigeria Customs and the business community.

Microsoft Windows inserts pop-up advertisements into Google Chrome

icrosoft has warmed up to Google Chrome by embracing Privacy Sandbox standards in its Edge browser. It's been observed that Microsoft is once again resorting to popup ads in Google's browser to encourage users to switch their default search engine to Bing.

Upon accepting the prompt, Bing becomes the default search engine instead of Google Chrome. Some users on Reddit expressed worries that these pop-ups resembled malware, sparking a discussion thread on the platform.

"Just randomly popped up on my desktop today, I couldn't find anything unusual in the task manager and computer is running fine," one Reddit user wrote. "Is it just an ad from Microsoft? Actual popup looked pixelated so wasn't sure. The links for the T&C link directly to Microsoft and did not have redirect links." Another Reddit user wrote: "Microsoft did put this exact Ad out, but there's nothing stopping malware from copying it. If the links were to Microsoft this was probably legit."

Caitlin Roulston, Microsoft's communications director, informed The Verge that the notification is a single instance offer, allowing users to opt for Bing as their default search engine on Chrome. She implied that this offer is advantageous for Windows users, as using Edge grants them additional chat turns in Copilot if they agree to the notification.

A user shared their perception that both Microsoft and Google are essentially adware and spyware companies.

Interswitch ventures into telecoms market with \$1m MNVO license

Interswitch, the Nigerian fintech behemoth backed by Visa, is set to make waves in Nigeria's telecommunications sector. Acquiring a Tier 5 Mobile Virtual Network Operators (MVNO) license from the Nigeria Communications Commission (NCC) for

500 million (\$1.08 million) in May 2023, Interswitch aims to redefine the telecom landscape.

The company's financial report outlines plans for a capital-efficient virtual telecoms model, blending payments and telecoms services for both B2B customers and consumers.

Nigeria, boasting Africa's largest phone market, operates a tiered MVNO licensing system, with Interswitch securing the coveted Tier 5 license. This enables Interswitch to collaborate with one of Nigeria's four major telcos, leveraging existing infrastructure to provide telecom services, particularly targeting underserved areas.



Interswitch's acquisition of the MVNO license occurred in 2023. The licensing system features five tiers delineating MVNO operations. The company plans to offer value-added services through its telco partnership.

This strategic move aligns with Interswitch's goal of bridging the connectivity gap by offering affordable 4G or 5G services, especially in rural regions. It comes at a pivotal moment for Nigeria's telco sector, witnessing its first growth decline in five years due to reduced capital expenditure and waning foreign investments.

In response, the NCC issued 25 MVNO licenses in 2023 to boost competition.

Despite Nigeria's population of 200 million, nearly 40% lack mobile connectivity, with a minority accessing high-speed networks.

Leveraging its extensive customer base—over 50 million debit cards issued through Verve—Interswitch aims to disrupt the telecom industry's incumbents, offering a compelling alternative.

However, thriving in Nigeria's fiercely competitive mobile market, with over 200 million subscribers, hinges on Interswitch's ability to deliver superior telecom services and forge strategic telco partnerships. Innovative approaches and value-added services will be crucial in navigating Nigeria's dynamic telco landscape successfully.

Mobile Ad spending hits record high

G lobal mobile ad spending surged to a remarkable \$362 billion in 2023, marking an 8% increase from the previous year, according to insights from Data.ai's State of Mobile 2024 report. The growth was primarily driven by revenue generated from short-form video and video-sharing apps. Projections indicate that this upward trend will continue, with mobile ad spending projected to reach \$402 billion in 2024, representing an 11% year-over-year increase.

In tandem with the rise in ad spending, mobile consumer spending also witnessed a significant uptick, reaching \$171 billion in 2023, marking a 3% year-over-year increase. The report highlights the growing attention towards social apps and the creator economy, which are emerging as new avenues for monetization beyond traditional advertisements.

Moreover, generative AI experienced explosive growth in 2023, with innovations such as AI chatbots and art generators fueling the integration of new features across various mobile sectors.

However, despite these positive trends, the mobile app marketing ecosystem faced unprecedented challenges in recent years. Apple's introduction of the App Tracking Transparency (ATT) framework in April 2021 significantly impacted marketers' ability to measure and optimize their campaigns, shifting the focus from user-level data optimization to aggregate data. Although alternative measurement solutions have emerged, confidence levels among marketers have yet to return to pre-ATT levels.

The Covid-19 pandemic further disrupted the mobile landscape, leading to rapid digital acceleration worldwide due to lockdowns and social distancing measures. While mobile apps capitalized on aggressive user acquisition campaigns during this period, a post-Covid digital cooldown ensued, with digital usage returning to pre-pandemic levels.

Adding to the complexity, the global economic downturn and rising inflation rates in 2022 had a profound impact on mobile businesses. Many consumerfacing mobile apps responded by reducing marketing budgets and staff, further compounded by the shock to the global economy caused by the war in Ukraine.

These developments contributed to significant volatility in the mobile advertising market. Between 2020 and 2021, Covid-19 and ATT shaped ad spend trends. Despite industry adaptations, the market saw a 5% drop in 2022 following a 40% leap in 2021.

Overall, while mobile ad spending has reached record highs, challenges such as regulatory changes, economic uncertainty, and evolving consumer behaviour continue to shape the landscape, necessitating adaptive strategies and resilience within the industry.

Operators fixing undersea cables to restore full Internet service - NCC

Communications Commission (NCC) said the cable operators have begun repair works and are gradually restoring services.

According to Reuben Muoka, Director

of Public Affairs, NCC, the cable operators promised to work round the clock to ensure that services are restored to the affected countries within the shortest possible time.

It would be recalled that there has been a continent-wide internet service disruption currently being experienced in Nigeria and other West African countries, including Ghana, Senegal, Cote de Ivoire, etc.

According to NCC, a combination of cable cuts, resulting in equipment faults on the major undersea cables along the West African Coast, have negatively impacted data and fixed telecom services in several countries of West Africa.

"The cuts occurred somewhere in Cote

de'Ivoire and Senegal, with an attendant disruption in Portugal.

"Cable companies – West African Cable System (WACS) and African Coast to Europe (ACE) in the West Coast route from Europe have experienced faults while SAT3 and MainOne have downtime," NCC said.

The Commission also revealed that similar undersea cables providing traffic from Europe to the East Coast of Africa, like Seacom, Europe India Gateway (EIG), Asia-Africa-Europe 1 (AAE1), are said to have been cut at some point around the Red Sea, resulting in internet service downtime across these routes.

Global oil and gas market size projects to reach \$9,347.9 billion by 2028

NNPCL deactivates over 6,000 illegal refineries linked to pipelines in Niger Delta

he Nigerian National Petroleum Company Limited, (NNPCL) has deactivated a total of 6,409 illegal refineries linked to the pipelines in the Niger Delta Region of the country.

This was disclosed by its Group Chief Executive Officer, Mele Kyari while receiving Ola Olukayode, Chairman of the Economic and Financial Crimes Commission (EFCC) in his office.

Kyari noted that the move was part of efforts to tackle the lingering cases of oil theft in the country.

According to him, going by the volume of oil stolen daily and the brazenness with which the perpetrators operate, crude oil theft is the most humongous and virulent economic crime in Nigeria that must attract the attention of the EFCC.

"We have deactivated 6,409 illegal refineries in the Niger Delta region. Today, we have disconnected up to 4,846 illegal pipes connected to our pipelines, that is out of 5,543 such illegal connection points. That means there are a vast number of such connections that we have not removed.

"These things don't just happen from the blues. They happen in communities and locations we all know. As we remove one illegal connection, another one comes up.

"This kind of thing does not happen anywhere else in the world. When we say illegal connections, they are not invisible things, they are big pipes that require some level of expertise to be installed. Some of them are of the same size as the trunk line itself. No one would produce crude oil knowing fully well that it is not going to get to the terminal. That is why nobody is putting money into the business. So, you can't grow production," he said.

While soliciting for partnership with the EFCC to curb the menace of oil theft, Kyari said that the very purpose of the Commission is to curtail economic crimes, and there is no bigger economic crime than what is happening in the oil and gas sector.

On corruption within the system, the GCEO explained that by law, NNPC Ltd is required to maintain high ethical standards and has put in place structures and measures to curb discretionary actions that fuel corruption, stressing that most processes in the company have been fully automated to discourage arbitrary actions.

In his presentation, Ola Olukoyede, the Chairman of EFCC, expressed satisfaction with NNPC Ltd's commitment to issues of ethics and code of conduct.

He, however, challenged management to ensure that the codes of ethics and regulations were complemented with monitoring and enforcement to enhance

Tesla resumes operation in German plant after arson attack

esla's factory near in Germany is gradually resuming production after being disconnected from the power grid for a week due to an arson attack. German energy network E.DIS confirmed that power has been restored since late Monday, enabling production to resume.

The attack, claimed by a group of far-left activists called the "Volcano Group," involved setting fire to an electricity pylon, resulting in the plant's power supply being cut off early last Tuesday.

According to a report from CNN affiliate RTL, production at the factory is expected to gradually increase, although it remains uncertain when it will return to full capacity, as stated by a Tesla spokesperson on Tuesday. Initially, Tesla had anticipated the shutdown to last until the end of the current week, as reported by the German media outlet.

Nevertheless, the shutdown could prove costly for Elon Musk's company. The substantial factory, situated approximately 30 kilometers (18 miles) southeast of Berlin, serves as Tesla's sole manufacturing facility in Europe and has a current annual capacity of producing 375,000 electric vehicles.

Model Y vehicles, the sole cars manufactured at the factory, have prices starting at \notin 44,990 (\$49,196) in Germany. This implies that a week's worth of output amounts to approximately \notin 324

million (\$354 million) in sales for Tesla.

Analysts had cautioned about a potential impact on firstquarter earnings if the shutdown persisted for about 10 days or longer. However, they noted that the subdued demand for electric vehicles (EVs) in Europe and the likelihood of Tesla compensating for lost production in the forthcoming weeks could mitigate the repercussions.
